

Downtown Improvements Dedication

Mid-October ushered in the long, awaited finish to improvements in the downtown business district, while the Chili Cookoff brought thousands to see the facelift and enjoy the festivities. Compliments have been generous regarding the results of the project, and everyone is proud of the final product.

Thiems Construction of Edwardsville was contractor on the job, which was designed by AAI/Campbell of Collinsville/St. Louis. Over 7,000 feet of new sidewalks, curbing and guttering, 3000 tons of asphalt and 150 new street lights were needed for the project, and 27 basement vaults had to be sealed and waterproofed before sidewalks could be poured. Over 600 feet of conduit was required for street lighting. It was a big job and it turned out great! A plaque commemorating the reconstruction is being installed in the near future.

Hidden Valley Ski Trip

Departure time will be 6:45 a.m. and returning time will be approximately 3:30 p.m. There will be doughnuts, milk and coffee served at the Roundhouse prior to departure. The cost of this event will be \$40.00 per person. This includes bus transportation, snow pass, rental equipment and a lesson. Actual ski time will be from 9 a.m. to 1 p.m.

Gymnastics


Senior Adult Program 55+

City Tax Rate

The Wood River City Council is holding the line on taxes, with Council members adopting the same projected tax rate as last year. Wood River has had a rate of \$1.36 to \$1.40 over the past four years, with the City maintaining a constant rate as prices and mandated expenses continue to soar.

The projected rate for 1993 is \$1,38 per each \$100 of assessed value. Fortunately, after years of decline, the City's total assessed value has edged up a little, so that our projected assessed value is now equal to that of 10 years ago, before Amoco shut down its refining operation.

State law requires that the City set the tax before the annual budget is prepared. The rate set in 1993 is for taxes to be paid in July of 1994. The 1994-95 budget will not be adopted until April of 1994, and the tax levy will have already been set.

If this sounds confusing, it is! Under any circumstance, the Council has said that the City will have to live with the present levy, and property owners can count on that.


A graduate of Edwardsville High School, Mark has a bachelor's degree in Business Administration from SIUE, and has attended the University of Illinois Police Training Institute.

Parking Lot #1 Improvements

Landscaping at the main parking lot between Wood River Avenue and First Street is nearing completion. Dirt has been added to shape a berm similar to that of the newer parking lot, between First and Second Streets. City crews have excavated a storm drainage trench and filled it with rock. Irrigation and landscaping work is now complete, and curb stops are to be added. Street lights on Madison and parking lot lights will be reworked for a pleasing appearance.

These improvements have been a shared expense between the City, as part of TIF improvements, and the Wood River Downtown Redevelopment Corporation, which has contributed over a third of the \$30,000 project cost. The two Madison Avenue parking lots enhance the new image of downtown Wood River.



The Hall of Fame recognition in this issue goes to two divisions of the Parks & Recreation Department: **Belk Park Maintenance and Park Maintenance**. Both divisions have supervised and completed an array of important projects this season.

Charlie Hall and the golf course maintenance staff deserve much credit for the excellent condition of our golf course. The maintenance staff did an excellent job keeping our course open and disease free this past summer, which was threatened due to the rain and high humidity. They also supervised the installation of a new irrigation system, landscaped the clubhouse, and improved the park and shelter areas around the lake.

Fred Gilliam and the park maintenance staff had numerous projects as well. Bill Mundy welded the hardware and mounting post for the new Benbow Field scoreboard. Bill also restored the old Benbow City jail used by the mayor in the chili cookoff. The park maintenance staff landscaped the downtown parking lots along Route 143 (Madison Aveue) and assisted with the landscaping at Belk Park Clubhouse. Other projects included building new dugouts at Emerick Sports Complex, installation of a new irrigation system at Central Park, and construction of a dumpster containment area at the Aquatic Center.

Department Director Jeff Stassi said "Our staff in Golf Course Maintenance and Park Maintenance should be proud of the number of fine accomplishments they have completed this year. They are hard working and dedicated to their jobs."

Farewell To Tom Amburg

The City and the Fire Department bid a fond farewell to Firefighter Tom Amburg, who is retiring after 23 years of service. In addition to being the station's "master chef", Tom's gentle demeanor and easygoing nature made him a calming influence at the worst fire.

Tom was actively involved in the implementation of the Southern Illinois Arson Investigators, and in 1978, the Wood River Fire Department was awarded the first Golden Flame Award for investigation in a major arson fire. Tom was named an Advanced Arson Investigator by the State of

Illinois in 1981.


A former ambulance attendant for Mark's Mortuary, Tom carried his emergency training to the department and was one of the City's first Emergency Medical Technicians. In 1989, he and coworker Tom Whalen received Exceptional Service Citations for saving the life of a young woman who had lapsed into cardiac arrest.

Beginning January 1, the Street Department will be operating without the services




of Bill Ruyle. Bill is retiring after 16 years of service. For the past several years, he has been the City's official street sweeper operator.

Library News

The Wood River Public Library is the recipient of a second Library of America grant from the Andrew W. Mellon Foundation. The grant will add the next ten volumes of the series, the only definitive collection of America's greatest writers, as they are published. The additional volumes will supplement the 60 Library of America volumes received

from the Mellon Foundation

in 1988.
Later this year the Library will receive two volumes of 19th Century American poetry, a landmark 2,000 page anthology presenting for the first time the great range of America's poetic voices. Contents range

from "Casey at the Bat" to Emily Dickenson; from "The Star-Spangled Banner" to "Go Down Moses", and include poetry of native Americans.

Other volumes the library will receive are the travel writings of Henry James, the works of Sinclair Lewis and Sarah Orne Jewett and the collected poems of Ralph Waldo Emerson.


The Friends of Wood River Public Library pledged

Common Sense Tips for Holiday Safety


From the Fire Department

Christmas Season is a wonderful time of the year. The last thing we would like to think about or deal with is an emergency. The fire department is keenly aware of the always present potential for dangerous situations. They feel extra precautions need to be taken during the holidays and offer the following common sense tips.

- Use the 9-1-1 service for all emergency calls
- Check all smoke detectors for fresh batteries

- Choose a live free that is not too dry and water it daily
 Lise only tree lights that carry U.L. label.
 Make sure the tree stand has a wide base and is sturdy
- All fireplaces should have a clean flue and be protected inside by a safe screen.
- Overloaded electrical sockets are extremely dangerous.
- Inspect extension cords for cracks or shorts
- Make sure extension cords are heavy enough to carry the load
- . Extension receptable bars with circuit breakers are your best be
- Be careful when decorating with Poinsettia and Holly, they are poisonous when
 - Make sure all steps and walkways leading to your home are safe for walking


Introducing New Businesses in Wood River.

When snow and ice cover the City, snow removal equipment is dispatched to clear the roadways for safe and easy access for travelers. The first priority is to remove snow from the arterial streets that are heavily traveled—these are called snow routes. Streets designated as snow routes are listed below.

SNOW ROUTES



Please remember, when we have a snow storm of two (2) inches or more accumulation, it is unlawful to park a vehicle on a snow route until said streets are cleared. So, if snow is predicted during the night and you live on a snow route, please move your vehicle off the street before you retire for the evening.

Parking on snow routes has been one of our biggest problems in snow removal. Crews must plow next to the curb to take care of our traffic needs. If you don't move your vehicle, the City cannot plow the streets in an acceptable manner.

The City will enforce the snow route ordinance by ticketing and towing vehicles parked on the snow routes. If a snow begins during the night, cars will not be ticketed until the next morning. If cars are not moved in one day, vehicles will be towed, at owners expense, so streets can be cleared.

We ask everyone's cooperation.



Business/Industrial Park Developments


Some giant steps have been taken to make our business/industrial park a reality. Don't expect to see industrial plants going up right away, but after years of plodding through paperwork, some tangible results are on the horizon.

In September, the City advertised for proposals on a specific site north of Koch Nitrogen. Although no proposals were received for that site, interest was generated in an adjoining location.

The River Bend Growth Association is still working with a potential prospect regarding the first site. If these two businesses locate in the new park, this will facilitate adequate funding for an entrance road that will open the whole park to display.

In the next few months, the City will be forming a new Tax Increment Financing (TIF) district, which will include the Industrial Park. Information will be distributed to the public and to all taxing districts explaining the TIF structure.





COUNCIL CORNER

As the New Year approaches, the City Council looks forward to exciting challenges. With the new Clark Bridge near completion and work underway on the I255 extension, the Council will focus its attention on the business park property on Route 3 & 143 and explore development possibilities.

Past Councils have realized the vast potential this property offers in the recruitment of new business and industry to Wood River. New transportation links soon to be completed will provide Wood River with an opportunity to make the business park and the City itself a crossroads of exciting happenings.

As a new member of the City Council, I feel we must do what we can to increase business and industry to bring additional jobs and revenues to the City. With additional revenue, the City can continue to provide and improve services to the citizens of Wood River without overloading the taxpayers.
