#### Promoted to Captain



# Notes from Planning & Zoning

Building Department
——"Just a reminder"

The City Inspector would like to remind Wood River residents and business owners that grass and weeds must be kept under 8" to comply with City Code. Residents are also reminded that according to City ordinance, a person's yard is described as extending from the middle of the alley to the front curb, side lot line to side lot line. The City asks that residents keep this in mind when they are maintaining their yard. Only with the cooperation of its residents can we keep Wood River a nice place to live.

#### Planning Department "Serving Wood River Businesses"

In an effort to better serve its local businesses, the City has recently started keeping information on the vacant commercial and indusrial buildings located in Wood River. This infomation is being kept in order to assist businesses who may be looking to expand or relocate within Wood River. Information kept in the City's files includes square footage of the building, site size, asking rent or sale price, and other information that is important to potential tenants or buyers. Persons wishing to have their vacant building added to the City's list may call 251-3100. Businesses needing additional space or wanting to relocate should contact the same number. The City will make every effort to assist its local businesses in finding a site in Wood River that fulfills their every need.

## Council Corner

You may have noticed improvements the City has made to make City facilities accessible to everyone. The most recent is the entrance to the Police Station on Acton Avenue. The step at the entrance was replaced with an accessible ramp and door aids were installed for easy access. These modifications were made possible through Federal grant money from Madison County Community Development.

Grant funds were also received to construct new accessible restrooms at City Hall and restrooms were also renovated at the roundhouse, plus a new ramp was constructed at the north entrance.

It takes time and money to complete the many things required for full accessibility. The City takes every opportunity we have to seek grant money to make these improvements. On May 1, an application was filed for 1996 grant funds to remove architectural barriers at the Library by installing door aids, renovating the restrooms and constructing a lift to the second floor. A lift for the Aquatic Center is also being requested.

The City Council is continually working towards full compliance with A.D.A. regulations so that all of our citizens can participate in City programs and utilize City facilities.

Also, I'd like to take this opportunity to thank all our residents for their patience and assistance with storm clean up during the last two storms. I noticed many residents clearing the leaves from the drains and hauling brush to the dumpsters. The City Council and staff appreciate your efforts.

# City Manager's Comments

The repeal of the Retail Rate Law by the State of Illinois was totally unexpected and a surprise to the City of Wood River. This Legislative action has seriously jeopardized the potential of the Polsky development of the Wood River Energy Center.

While the Polsky project may not become a reality, the City still has a viable and marketable business park. We will continue to market the business park in an aggressive manner in order to create developments within the park which will enhance the City of Wood River's property tax base. At the current time, we have two tenants who plan to construct new buildings during the upcoming building season.

I would also like to thank all our citizens and businesses for their efforts in communicating with the Governor's office in regards to the Retail Rate Legislation. Your efforts are deeply appreciated and show your concern for the future economic viability of our region.

The City's new fiscal year recently began on May 1. Every year the City adopts a budget for the current fiscal year. This year's budget represents a decrease of \$1.4 million from last year's budget. This decrease is necessary due to the declining tax base of the City from the Amoco re-assessment and the economic conditions of our area. We will strive to provide efficient and effective service to our citizens.

The City has also enacted changes in the rate structure for the operation of the 14th Street waste facility. These changes include the addition of a charge of \$.50 per bag for landscape waste. Landscape waste has been banned from landfills since 1990. The increased disposal costs of these items necessitated a charge being placed upon the user of this service. A rate structure has also been adjusted for the disposal of waste items.

At the current time, work continues on the development of the connector road which will connect Illinois Routes 143 and 111. This project is scheduled to be completed by July 31, 1996. This will be a welcomed addition to the City of Wood River.

The summer season also allows our residents to enjoy various recreational opportunities, such as softball leagues, youth baseball leagues, the Aquatic Center which opens on Saturday, May 25 and Belk Park Golf Course which continues to be highly regarded as a public golf course facility in the St. Louis Metropolitan area.

I would also like to thank our residents for their assistance during the recent rash of storms that hit the City of Wood River. Your assistance with the removal of debris from storm water catch basins helps in the draining of storm water. These efforts are appreciated in all neighborhoods of our community.
